TERMS & CONDITIONS

By signing this purchase agreement, the BUYER is agreeing to all the terms therein & is legally obligated to uphold these terms. The BUYER is agreeing to pay fines, cover medication costs, & cover other costs not limited to legal fees, travel expenses, gas fees, lodging for hearings, & any subsequent related costs accrued by the breeder should violation of this purchase agreement occur.

1. A **non-refundable HOLDING FEE of \$500** is required to RESERVE a kitten. Should the BUYER decide not to adopt the cat/kitten listed in this contract, the holding-fee is either forfeited or transferred to a different cat/kitten, either in a current litter (if available) or a future litter on a first-come-first-served basis. In the event that a reserved cat/kitten dies in the BREEDER's care, the BUYER may select another cat/kitten of like kind & quality as soon as one becomes available. Should the BREEDER cancel the sale, the holding fee will either be transferred to a different available cat/kitten OR the BREEDER may choose to issue a refund.
2. The cost of the kitten/cat includes the first vet visit. **Payment in full is due upon receipt of kitten at in-person pick-up.** The BREEDER accepts payment in cash &/or Zelle. If the BUYER requests delivery, the BUYER is responsible for all transport costs, in addition to payment in full for the kitten.
3. All kittens are registrable with limited (pet) registration through "The International Cat Association" (TICA) OR "The Cat Fancier's Association" (CFA). They will have received age-appropriate vaccines, rabies vaccination & deworming. BREEDER encourages all BUYERS to research vaccinations & the benefit to risk ratio involved. If the BUYER opts to give additional vaccines, the BREEDER is not liable for any illnesses or side-effects that may occur.
4. The BREEDER is not liable or responsible for the welfare of the cat/kitten after it leaves the cattery. Whether that is by direct hand-off, courier, or shipping of any kind. It is the BUYER's responsibility to have the animal insured appropriately. All claims should be filed with the appropriate parties. The BREEDER is not liable if the cat/kitten is lost, stolen, injured, killed or adversely impacted while in transit.



5. All Kittens / cats MUST be fixed (spayed or neutered) at 6 MONTHS OLD. If the terms of this pet adoption contract are broken, the BUYER understands that the BREEDER is to receive 5 TIMES the worth of the kitten in small claims.
6. The BUYER agrees to provide a life-long commitment, comfortable environment, prompt medical attention, proper diet, proper housing, & responsible routine care for this kitten.
7. No part of any correspondence may be copied, forwarded, or shared by the BUYER. This includes, but is not limited to, phone calls, voice mails, texts, emails, private messages, social media contact, posts, comments & discussions. ANY discussion of the BREEDER that could be deemed slander, libel, or damaging to the BREEDER may result in litigation & restitution.
8. The BREEDER does not recommend the declawing of any kitten/cat, and is not liable should complications, death, or behavioral changes occur as a result.
9. If at any time the BUYER can no longer take care of the kitten/cat, the BREEDER agrees to accept the kitten/cat back. There will be no refund of the purchase price.
10. The BREEDER guarantees that the kitten/cat is healthy to the best of their knowledge at the time the BUYER takes ownership of the cat/kitten. Once the BUYER has taken possession of the cat/kitten, the BREEDER will not be held responsible for any medical bills whatsoever, this includes FeLV, FIV, FIP, Stomatitis, bacterial or viral infections, infectious diseases, parasites or fungus. A 30-day health-insurance policy is provided with each kitten. It is the BUYER's responsibility to activate & maintain health insurance on the kitten once it leaves the cattery.
11. The cat or kitten has a one-year guarantee (from the date of birth) against genetic defects which results in death. The BREEDER will replace the kitten when the following terms are met:
 - Proof-of-defect from a licensed veterinary specialist or necropsy is received.
 - The BUYER agrees to release all of the cat/kitten's veterinary records to the BREEDER, & must give permission for the BUYER's veterinarian to discuss the case with the BREEDER.



- The cat/kitten must have received yearly exams, & be current on core vaccinations & rabies vaccination.

All cats will be replaced with another kitten of like kind & quality as soon as one becomes available. There will be no refunds under any circumstances except at the BREEDER's discretion if he/she opts to refund the purchase price rather than replace the cat.

12. This pet application & contract is legally binding to all parties involved. This sales agreement is non-transferable to other parties. Any changes, additions or omissions to this contract must be agreed upon in writing & dated by all parties. Breach of this agreement will result in cancellation of any warranties, or guarantees of this kitten. The BREEDER's maximum liability to the BUYER for any & all losses, claims, damages or liability of any kind shall be limited to the amount paid by the BUYER to the BREEDER under this agreement. Any lawsuits pertaining to this agreement will be handled in Cattaraugus County within the state of New York.
